Subject: Compliance pursuant to Regulation 51(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015

Pursuant to Regulation 51(1)&(2) read with sub-clause 6 of clause A of Part B contained in Schedule III of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 with respect to disruption of operations due to natural calamity i.e. pandemic-COVID 19, we hereby intimate the Exchange that the Bank's operations fall under essential services and consequent to various regulatory guidelines Bank's operations are continuing on a limited scale post the nationwide lockdown announced by Government of India.

The Bank has invoked the Business Continuity Plan to ensure unhindered customer service through curtailed branch business hours and digital banking channels. The Bank has been submitting necessary reports to RBI on a daily basis to apprise them of the Bank's operations during the lockdown period. Periodic updates have been submitted to the Board of Directors. The Bank is also committed to meet all its payment obligations in time. Till date there has been no deferment/delay in meeting timely repayment obligations to lenders/debenture-holders.
